III. **Discussion of Forestry Plan Submitted by the State Regarding Select Harvest of Timber:** Presentation at meeting by town staff and Mike Kay, Forest Service, Department of Natural Resources. Copies of draft *Forest Stewardship Plan* and maps provided at town meeting.

2013 Forest Stewardship Plan Talking Points

- Area 947 acres of forest, 23 acres of fields, 17 acres of reservoir. This is off of Hampton Valley and Crystal Fountain Roads.
- Tract is part of the Upper Monocacy watershed.
- The following are objectives of a Forestry Plan
 - o Primary Soil and Water Conservation
 - o Secondary Recreation, Wildlife, Forest Products, Fisheries
- Plans should be revised every 15 years.
- The MD Forest Service conducted the first forestry plan for this area in 1949.
- Another plan was complete in 1963, and a number of commercial harvests occurred throughout 1963-1965. Noncommercial timber stand improvements were carried out in 1966.
- The MD Forest Service prepared another plan in 1981.
- In 1984, Consultant Forester Harry Staley prepared a new plan. Forester Staley managed this property until his passing in the early 2000's. During this period, a number of commercial and noncommercial thinning's were conducted.
- In 2007, a plan developed by Glatfelter Pulpwood Company's Forester Scott Kurtzman was prepared for this property. Glatfelter crews have performed a number of thinning operations and some weed control practices from the 1960's until present.

2013 Forest Plan

- Prepared by Michael Kay of the Maryland Department of Natural Resources.
- Acreage is broken into 18 "stands." A stand is a basic forest management unit. A grouping of trees, which are uniform in species composition, age arrangement, and condition, and are distinguishable.

The 2013 plan concluded:


- Forestry Issues on Watershed
 - 1. Insufficient tree regeneration in some areas due to deer feeding and invasive plants.
 - 2. Areas where a significant number of oak are declining or dead due to gypsy moth defoliation and oak decline.
 - 3. Areas where the roads and trails are blocked with downed trees.
 - 4. Areas where a significant amount of at risk ash are present from ash decline and emerald ash borer.


- Timber Sales proposed (select harvest not clear cut):
 - 1. Stand 5 Salvage/Intermediate Harvest 60 Acres
 - 2. Stand 6 Salvage/Intermediate Harvest 45 Acres
 - 3. Stands 7 & 8 Intermediate & Regeneration Harvests 49 Acres
 - 4. Stand 11 Commercial Timber Stand Improvement 33 acres
 - 5. Stand 15 Intermediate Harvest 36
- Noncommercial timber stand improvement activities proposed:
 - Stand 8 weed control 39 acres
 - o Stand 9 crop tree release 52 acres

Suggested Timeline

- October 15, 2018 Board permit the implementation of the 2013 Forestry Plan.
- Winter 2018/2019 Mike will mark trees & estimate a market value of the timber. He said the average revenue generated from a select harvest is \$1,000 per acre. Mike will assist staff prepare an RFP. The RFP will be sent to saw mills for their bid on the trees. A contract will be signed with a timber company. Takes approximately 1 year to cut the timber. Mike will ensure contractor compliance with the contract. The Maryland Department of Natural Resources committed to provide all services **FREE**. A private contractor usually charges at least 10% fee of the total timber revenue generated from the harvest.
- Fall 2019 Select harvest Stands 5 & 6 105 acres
- 2020 Select harvest Stands 7 & 8 49 acres
- 2021 Select harvest Stand 11 33 acres
- 2022 Select harvest Stand 15 36 acres
- 2028 Prepare a new forestry plan.

Potential revenue generation - \$223,000.
