CONDITIONS OF USE:

1. Watershed use is limited to daylight hours. No trespassing is permitted from dusk to dawn.
2. Parking in front of cabled road/path areas is prohibited. Violators will be towed at their expense.
3. Nohunting within 150 feet of the established safety zones, as shown on the Town's watershed map (see back of this form).
4. Fishing is permitted only at Rainbow Lake. All other reservoirs in the Town's watershed property are off limits.
5. Hunting is for Emmitsburg residents with a valid Emmitsburg address**. ** 21727-Zip Code
6. Boating, swimming, ice fishing, or ice skating is prohibited.
7. Injury, defacement, disturbance of any building, sign, or public property and, except under specific permit, the removal or destruction of any tree or other plant or mineral is prohibited. The permittee agrees to assume responsibility for any and all property damages.
8. Permanent tree stands are prohibited.
9. Refuse and rubbish must be properly disposed of in receptacles provided for that purpose. Any litter or waste materials on the lands or waters of Emmitsburg's watershed are prohibited.
10. Alcoholic beverages, controlled dangerous substances and gambling are prohibited in the watershed.
11. Smoking is prohibited in the watershed.
12. Camping and fires are prohibited.
13. Loud, disturbing noises from a radio, music instrument, or similar device are prohibited.
14. No person may do obscene or indecent acts; annoy people, interfere with, encumber, obstruct or render dangerous any drive, path, walk, or public place; and/or engage in, instigate, and/or encourage a contention or fight, or assault a person.

15. All-terrain vehicles are prohibited in the watershed.
16. No animal may be brought upon watershed property unless it is on a leash and is at all times entirely within the control of the person(s) bringing it upon the watershed property.
17. The Town, its agents and employees shall not be liable for any loss, damage, injury or casualty of whatsoever kind or by whomsoever caused to the person or property of anyone on or off the premises, arising out of or resulting from the permittee's use, possession or operation thereof, or from installation, existence, use, maintenance, condition, repair, alteration, removal, or replacement of any equipment thereof, and the permittee hereby agrees to indemnify and hold the Town of Emmitsburg, its agents and employees harmless from and against all claims, demands, liabilities, suits or actions for such loss, damage, injuries or other casualty.

Any person(s) violating the provisions of this permit may be issued a civil citation and, upon conviction, be punished by a fine up to one thousand dollars (\$1,000.00) and/or imprisoned. Any person(s) violating any Federal, State, County, or local law ordinance in force and applicable in the watershed property, shall upon conviction thereof, be punishable in accordance with the applicable penalty provisions of the law or ordinance.

Any person who engages in any improper use of the watershed area will be permanently suspended from use of the area.
