The Town has received 12 applications requesting a total of \$92,430 of an available \$50,000 in FY2023 Community Legacy grant funds. Mr. Long read aloud the list of applicant property addresses, the funds requested and the property restoration guidelines the work group needs to consider when awarding funds. The group set forth to prioritize and review for approval or disapproval 12 applications. 125 North Seton Avenue was established as a priority project due to the project not being funding in FY2022. 351 East Main Street, 401 West Main Street and 115 DePaul Street were also established as priority projects due to health and safety concerns. The group awarded funds to the properties as follows:

- J. 401 West Main Street - \$10,000
- K. 513 West Main Street - \$1,437.50
- L. 115 DePaul Street - \$2,970
